In 1999, he took over the financial management of Darty Ile de France, and then moved to But in 2006 as CFO before assuming the responsibilities of Vice-President in charge of Finances for the Kesaelectricals group (Darty) where he remained until 2012. He was then appointed Administrative and Financial Director of French operations for the Korian Médica group before joining Elior.

Eric Schwartz took up his functions as Administrative and Financial Director of Elior Contract Catering France on 17 September this year.
